1. This Invitation for Tenders follows the general procurement notice for this project which appeared in the Development Business issue No. WB 320-696/07 dated August 2007.
2. The Kongwa District Council has been allocated funds from the Government of the United Republic of Tanzania for the operation of the Rural Water Supply and Sanitation Sub-Project during the financial year 2016/2017. It intends that part of the proceeds of the fund will be used to cover eligible payment under the contracts for Construction of Two Water Supply Projects at Matongoro and Chiwe Villages in Kongwa District Council.
3. The Kongwa District Council now invites sealed tenders from eligible National contractors registered in Civil Works class V and above for Construction of Water Supply Pumped Scheme Project at Matongoro and Chiwe Villages in Kongwa District Council as indicated below;

4. Tendering will be conducted through the National Competitive Tendering procedures as specified in the Procurement Regulations 2013 – Government Notice No.446 and is open to all Tenderers as defined in the Regulations unless otherwise stated in the Tender Data Sheet.
5. Interested experienced and eligible Tenderers may obtain further information from and inspect the Tendering Documents at the office of **The Secretary, Kongwa District Council's Tender Board, P. O. Box 57, Kongwa** from 08:00 a.m to 03:30 p.m on Mondays to Fridays inclusive except on public holidays.

A complete set of Tendering Document(s) in English language and additional sets may be purchased by interested Tenderers upon submission of a written application with full and reliable contacts information upon payment of a non-refundable fee of one hundred thousand only Tanzanian shillings (100,000.00) to be effected through bank where by the Tenderer collects the payment bill from the Council's revenue office (room no.15), deposit the money to the bank, submit the pay-in slip to cashier's office(room no.24) where he will be issued the electronics receipts and submit it to PMU's office room(room no.18) where the tender documents are issued.
7. All the tenders must be accompanied by a tender Securing Declaration in the format provided in Section X of this Tendering Document.
8. All tenders in original plus one Copy, properly filled in, and enclosed in plain envelopes must be delivered to **The Secretary, Kongwa District Council's Tender Board, P.O.Box 57, Kongwa.** at or before 10:00 am on Monday, June 05th, 2017. Bids will be opened promptly thereafter in public and in the presence of Tenderers or their representatives who choose to attend in the opening at Kongwa District Council.
9. Late tenders, portion of tenders, electronic tenders and tenders not received, tenders not opened at the tender opening ceremony shall not be accepted for evaluation irrespective of the circumstances.
10. All Tenderers who wish to tender for the above works are highly encouraged to attend Pre – Bid Meeting on Monday, May 29th, 2017 from 10.00a.m at Kongwa District Council and attend the site visit thereafter.
